## **RANGE ACTION SAFETY PLAN (RASP) FOR RECREATIONAL SHOOTING AT THE NATIONAL SHOOTING CENTRE (NSC) BISLEY**

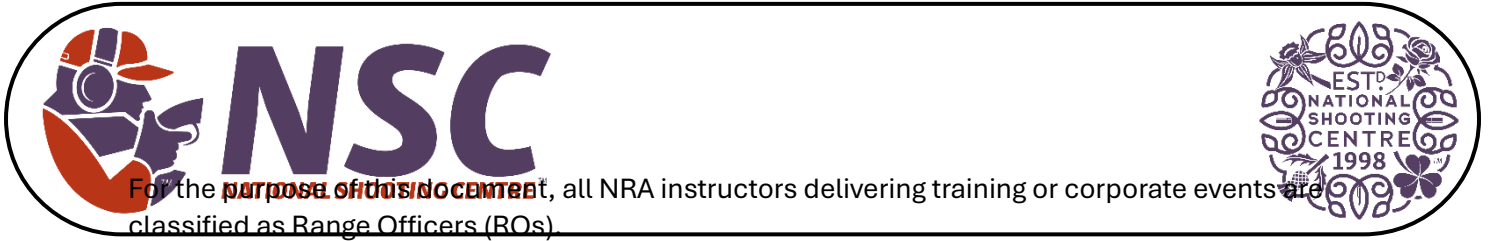
### **1. General**

This RASP governs the safe conduct of shooting at the National Shooting Centre, Bisley. All users of the ranges are bound by this plan, except HM Forces and government agencies operating under their own procedures with prior approval from the National Rifle Association (NRA).

Recreational shooting is permitted seven days a week, up to 52 weeks per year, on the following ranges:

1. Stickledown
2. Butt Zero
3. Century
4. Short Siberia
5. Cheylesmore
6. Melville
7. Winans
8. Zero
9. Chobham Ridge
10. BSR
11. NCSC
12. BSG

**Note:** NRA members and staff authorised to shoot outside designated rifle ranges must sign on at the Range Office, specifying the area and activity. Where required, specific Range Orders must be signed and retained by the Range Office.



## 2. Aim

The objectives of this RASP are to:

1. Ensure rapid and effective response to incidents and occurrences
2. Define the duties and responsibilities of NRA Range Staff
3. Detail points to cover in Range Safety Briefings

## 3. Incident Response

### 3.1 Immediate Action

On hearing the **Emergency Hooter** or **“STOP STOP STOP”**, all personnel must:

1. Cease firing immediately
  - . BSG to inform instructors / Ros within Cottesloe Heath
2. Remove finger from trigger and keep firearm pointed at the target
3. Lower manually marked targets (where applicable)
4. Await instructions from Range Staff

The CRO/RO responsible for the area must inform Range Control immediately. All Range Staff are to switch to the Control radio channel, minimise traffic, and await further instructions.

5. Range Control are to call **“STOP STOP STOP”** over the control and admin radio channels

Range Safety will assume Incident Control on the ground, liaising with emergency services if not already contacted.

Range Control will assume Incident Coordination and liaise with Range Safety regarding assistance required.

6. Any staff or contractors who are situated on any range floors/danger areas are to remain in position until instructed otherwise by Range Control

### 3.2 Medical Emergencies

#### First Aid Provision:

- NRA-qualified staff are available
- First aid kits and trauma packs are deployed at designated locations

#### Actions for casualties or ill members:

1. If safety is compromised, initiate the Immediate Action Drill – **“STOP STOP STOP”**
2. RO/CRO informs Range Control

3. RO/OBO clears the firing point to allow safe access when instructed by Range Staff
4. Range Control deploys a first aider with appropriate equipment
5. Range Safety calls emergency services (999) if required
6. Range Control deploy a guide to the Emergency RV – main gate if requested
7. Range Office informs the CEO, Head of Shooting, and Range Services Manager if they are not on site

#### **Additional Considerations Off-Range:**

- First aid provisions must be evaluated before commencement of any off-range activity

### **3.3 Preservation and Reporting**

RO responsibilities (when appropriate):

- Preserve all evidence
- Record witness names
- Complete an Incident Report promptly
- Cooperate fully with investigation teams

### **3.4 Unexploded Ordnance (UXO)**

If suspected UXO or military hardware is found:

1. Initiate STOP STOP STOP
2. Inform Range Control who will dispatch Range Safety
3. Range Safety are to coordinate the below actions:
  - **Confirm** without touching that the object may be UXO
  - **Clear** the area – Ensure all firearms are safe and move personnel out of the area (minimum **100m radius**)
  - **Cordon** – ensure people of vehicles do not approach the object
  - **Control** - manages the situation until specialist staff arrive.

## **4. Safe Persons and Responsibilities**

## Responsibility

Role	Responsibility
<b>Chief Executive Officer (CEO)</b>	Overall authority for NRA operations
<b>Head of Shooting and Training</b>	Oversight of shooting activities
<b>Range Services Manager</b>	Day-to-day range safety and maintenance
<b>National Training Manager</b>	Training oversight
<b>Safety, Legal &amp; Technical Manager</b>	Regulatory compliance and guidance
<b>Range Safety Personnel / Range Control Personnel</b>	Direct supervision of firing and safety
<b>Chief Range Officer (CRO)</b>	Supervises ROs; responsible for safe conduct of the practice
<b>Range Officer (RO)</b>	Responsible for live firing, personnel, discipline, and adherence to Range Regulations
<b>Safety Supervisors (SS)</b>	Assist ROs in supervising firing points
<b>Butts Officer/Supervisor</b>	Supervise target markers in the butts, PPE compliance, and target presentation

## 5. Safe Places and Range Familiarity

- RO's/CRO's must have read, understood and will adhere to the "Duties of the RO", "NSC Range regulations", Specific Range Regulations, and the RASP documents.
- ROs/CROs must be fully familiar with the range, constraints, and facilities.
- Recce visits are mandatory for unfamiliar ranges and can be conducted on the booking day.
- Ranges are inspected monthly by: MOD, CNC, and NRA, and are maintained annually.

## 6. Safe Firearms and Equipment

- CRO/RO ensures all firearms and ammunition are permitted per Range Regulations.
- Users are responsible for ensuring that their firearm is safe.
- NSC hire firearms are inspected and serviced by NRA armourers prior to issue.

## 7. Safe Practices

### 7.1 Risk Assessment

- Standard shooting follows the NRA Safe System of Shooting.
- Non-standard practices (e.g., movement drills) require prior Range Control approval and activity-specific risk assessment.

- RO ensures firers and bystanders have serviceable PPE before shooting begins.

### 7.3 Safety Briefings

**RO Support Personnel (RO/SS) Briefing** includes:

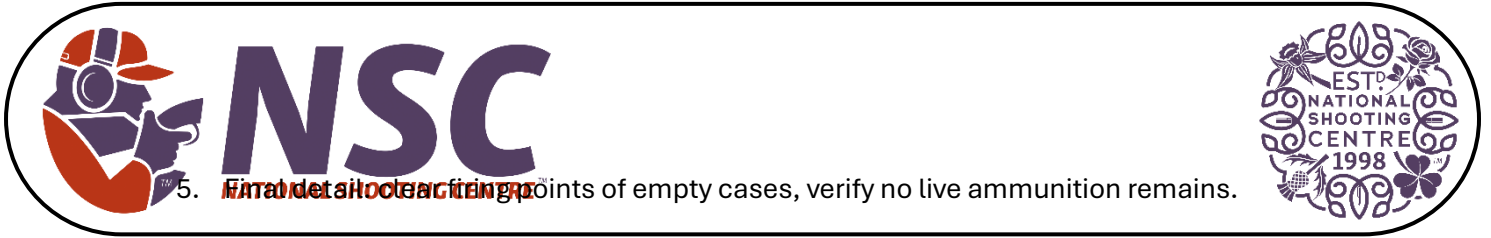
1. Communication and emergency procedures.
2. Overview of range activity and neighbouring activities.
3. Sequence of events.
4. Range-specific regulations.

**Firers Briefing** includes:

1. Signals for **start and cessation of firing**.
2. Emergency signal (**Emergency Hooter or “STOP STOP STOP”**).
3. Action on emergency signal:
  - Cease fire immediately
  - Remove finger from trigger
  - Keep firearm pointed at target
  - Follow CRO/RO instructions
4. Medical cover
5. Permitted firearm states
6. Details of the practice

### 8. Completion of Each Detail

1. Firers ensure firearms are cleared and independently inspected in accordance with NRA Safety Rules before being removed from the firing point.
2. Unloading procedures include:
  - Safety catch applied
  - Magazine removed
  - Integral magazine/cylinder emptied
  - Chamber and action cleared or rounds, misfires and empty cases
  - Working parts fully open and locked
3. The chamber, action, bolt face and magazine may then be inspected with bolt removed / breech flagged / magazine blocked.
4. No forward movement of firing point until procedure is complete.
