Century <b>Butt 19 mantlet</b></li> </ol> </li> <li>2. <b>Access:</b> <ol style="list-style-type: none"> <li>a. The Butts are to be accessed via the Target Shed Road passage. Over the mantlet is not permitted</li> <li>b. All firers must access the 200yd firing point from the car park, passage across the range floor is not permitted</li> <li>c. All shooting must cease to allow access to/from Stickle-down Butts</li> <li>d. Civil police are only allowed to shoot from a maximum distance of 40m with rifles and 14m with pistols where access to Stickle-down is required or stop butt maintenance is occurring</li> </ol> </li> <li>3. Vehicles are not permitted on the range floor</li> <li>4. Fire with movement is not permitted</li> </ol> |

Prone</li> <li>b. Supine</li> <li>c. Sitting</li> <li>d. Kneeling/Squatting</li> <li>e. Standing</li> <li>f. Benched</li> </ul> <p>11. Lanes 1-4 are restricted to benched position only.</p> <p>12. Sporting stances on electronic targets are only permitted up to 100x</p> <p>13. Permission to fire from any position other than prone/supine, or use a muzzle brake, must be notified in the booking request and granted by the Range Office in order to allow suitable target allocation on the range.</p> <p>14. Changes of position are permitted within any detail or practice outside competition providing all firers follow the same sequence, and in competition in accordance with the conditions.</p>                                                       |
| <p><b>Targetry</b></p>                     | <p>15. Unless prior permission has been obtained from the CE only targets from the NRA approved set may be used</p> <p>16. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and /or appropriate shooting station or peg. Any deviation from this is to be notified, in writing, and approved by the Range Services Manager</p> <p>17. Handheld targets are only to be exposed in or in front of target frames</p> <p>18. Handheld targets not supplied by the NRA require to be notified at the time of the booking due to possible frame removal</p> <p>19. Laterally moving targets are not permitted on Gallery ranges</p> <p>20. Falling plates or other hard targets may not be engaged at a distance of less than 25yds (22 metres) without the permission of the CE</p> <p>21. Users are not permitted to provide their own hard targets.</p> |
