FIREARMS AND AMMUNITION

Running Deer iii. 50yd Zeroing Range b. Melville c. Stickle-down d. Pirbright <p>2. Access:</p> <ol style="list-style-type: none"> a. All movement forward of the Running Boar firing point requires the following ranges to have ceased fire, and must be coordinated by the BSR manager or delegate: <ol style="list-style-type: none"> i. Running Boar ii. 50yd Zeroing Range

	<ul style="list-style-type: none"> iii. Statics iv. Running Deer b. When there are personnel forward of the firing points, the red flag system is to be followed under the direction of the BSR Manager or delegate 3. A maximum of two shots are permitted per run of the moving target <ul style="list-style-type: none"> a. Another shooter can dry fire from the alternate lane 4. Vehicles are not permitted on the range floor without prior permission from the BSR manager
Firing positions	<ul style="list-style-type: none"> 5. All firing is to be conducted from the range hut 6. Positions permitted: <ul style="list-style-type: none"> a. Benched b. Standing
Targetry	<ul style="list-style-type: none"> 7. MAX TCH: 1.5m 8. Only targets from the BSR approved set may be used 9. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and/or appropriate shooting station or peg. 10. Moving Target is to be engaged from a maximum of 50m. 11. Falling Plates or other hard targets may not be engaged within Running Boar Range
