RANGE REGULATIONS FOR SHORT SIBERIA RANGE

Description	<p>Type: Gallery Range</p> <p>Danger area: Limited Danger Area (LDA) / Full Danger Area (FDA) for police use</p> <p>Location (What 3 words): Stamp.Sobs.Swear</p> <p>Distance: 5m – 200yds</p> <p>Targets:</p> <ul style="list-style-type: none"> • 27 lanes at 100yds • 9 lanes at 200yds (19-27) • McQueen Castles (sighting target) can be fitted on Lanes 20 (21), 22 (23), 25 (24) for use at 200x only • 28 target turners (4x banks of 7) at 5m – 100m • 8 static frames at 10m – 25m <p>Additional notes:</p> <ul style="list-style-type: none"> • Lanes 1 – 4 are undercover and have 2x fixed benches per lane • Lane 5 is undercover and has a single fixed bench
FIREARMS AND AMMUNITION	
Permitted firearms and ammunition including ME & MV	<p>Type: Rifles; gallery rifles. Shotguns and pistols by special arrangement only</p> <ul style="list-style-type: none"> • Maximum Muzzle Velocity: 1000 m/s (3280 ft/s) • Maximum Muzzle Energy: 4500 J (3319 ft/lb) • HME Permitted: 4500J – 7000J HME procedures apply
RANGE SAFETY LIMITATIONS	
Coordinating Instructions	<ol style="list-style-type: none"> 1. Shooting on this range affects the following ranges: <ol style="list-style-type: none"> a. Stickledown b. Century Butt 19 mantlet 2. Access: <ol style="list-style-type: none"> a. The Butts are to be accessed via the Target Shed Road passage. Over the mantlet is not permitted b. All shooting must cease to allow access to/from Stickledown Butts c. Civil police are only allowed to shoot from a maximum distance of 40m with rifles and 14m with pistols where access to Stickledown is required or Stickledown stop butt maintenance is occurring 3. Vehicles: <ol style="list-style-type: none"> a. Are not permitted on the range floor without prior permission from the range office b. Golf buggies are permitted. In extreme weather

	<p>conditions, Range Safety may restrict their use in certain areas where necessary.</p> <p>4. Fire with movement is not permitted</p> <p>5. When shooting target shotgun at the left hand static targets the relevant butt target frames are to be removed from the cantilever frames and the frames fully lowered into the trough</p>
<p>Firing Positions</p>	<p>9. All firing is to be conducted from the left of pegs</p> <p>10. Positions Permitted:</p> <ul style="list-style-type: none"> a. Prone b. Supine c. Sitting d. Kneeling/Squatting e. Standing f. Benched <p>11. Lanes 1-4 are restricted to benched position only.</p> <p>12. Sporting stances on electronic targets are only permitted up to 100x</p> <p>13. Permission to fire from any position other than prone/supine, or use a muzzle brake, must be notified in the booking request and granted by the Range Office in order to allow suitable target allocation on the range.</p> <p>14. Changes of position are permitted within any detail or practice outside competition providing all firers follow the same sequence, and in competition in accordance with the conditions.</p>
<p>Targetry</p>	<p>15. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and /or appropriate shooting station or peg. Any deviation from this is to be notified, in writing, and approved by the Range Services Manager</p> <p>16. Self-provided targets may be used with permission from the Range Office and in line with the following:</p> <ul style="list-style-type: none"> a. Lanes 9 – 18 may only be fixed level and above the target centre height b. All remaining lanes are permitted anywhere within the 0.9m x 0.9m correx pin - on <p>17. Handheld targets are only to be exposed in or in front of target frames</p> <p>18. Handheld targets not supplied by the NRA require to be notified at the time of the booking due to possible frame removal</p> <p>19. Laterally moving targets are not permitted on Gallery ranges</p> <p>20. Users are not permitted to provide their own hard targets.</p>
