

## **CHEYLESMORE RANGE ORDERS FOR AFTER HOURS SHOOTING**

### **Reference:**

- A. Bisley Ranges Regulations
- B. Cheylesmore Bay B Regulations

1. These range orders complement Reference A and B, and apply specifically to the use of Cheylesmore (Bay B) Range outside of normal shooting hours.

### **General**

- 2. Cheylesmore (Bay B) is a No Danger Area (NDA) 25m range providing 4 x banks of 5 turning targets
- 3. Due to its classification as an NDA Range, Cheylesmore (Bay B) Range may be used outside of normal shooting hours, subject to compliance with the regulations and conditions listed within Reference A and B, and below.

### **Firearms**

- 4. The firearms permitted to be used within Cheylesmore Range are restricted to a maximum MV of 655 m/s and a maximum ME of 2030 J.
- 5. Small-bore target rifles may be used for prone or 3-position shooting to NSRA or ISSF rules with prior permission from the Range Office.
- 6. Black Powder rifles and pistols may be used with the prior permission from the Range Office.
- 7. Shotguns may not be used within Cheylesmore Range.

### **Targets**

- 8. Targets are to be mounted in the frames or holders provided and are only to be engaged from the recognised firing points. The following restrictions apply:
  - a. Hard targets are not permitted
  - b. No laterally moving target may be used

### **Supervision**

- 9. All out of hours shooting is to be overseen by a nominated RO who is responsible for:
  - a. Signing these range regulations on the attached certificate and in doing so accepting responsibility for all aspects of the activity
  - b. Compliance with all relevant Bisley rules and regulations, including these Range Orders
  - c. Ensuring that all personnel shooting are correctly qualified and entitled to do so
  - d. Ensuring that unqualified personnel are correctly supervised, a safety supervisor is required for each unqualified firer

- e. Ensuring that any firearm malfunctions are reported and if required the firearm is secured in the allocated ballistic safe within the range complex
- f. The security of the range during and on completion of the event, this includes ensuring all doors are locked and the alarm is set.
- g. Ensuring that no alcohol is taken in to the Range complex
- h. Appointing a correctly qualified First Aider who is present during the event
- i. Ensuring that a functioning means of contacting the emergency services is available at all times on the range when it is in use
- j. Ensuring that enough people are present so that, if an incident occurs, control can be maintained and First Aid provided while sending a person with a vehicle to the main gate to guide emergency services
- k. Collection and return of the keys and target remote controls from the Range Office
- l. Signing on to the Range, in the Range Office, on the day of the event, at least 15 minutes prior to office closure.
- m. Ensuring that firing ceases by latest 2100hrs
- n. Reporting occurrences to the Range Office

## **Safety**

- 10. Ear defence is mandatory.
- 11. All shooting is to be from a single firing line.
- 12. Cross lane firing is not permitted.
- 13. In the event of an injury or accident, the RO is to seek assistance from the emergency services by dialing 999. In the event of any accident the RO is to inform the Range Services Manager (07824665182) or alternatively 07876444482. The RO is to report all other occurrences in accordance with Reference A to the Range Office at the earliest practicable opportunity.
